## **LESSEE AGREES TO:**

- 1. Bring vehicles in between the hours of 8 am and 12 pm (noon) on Saturday, November 1, 2025.
- 2. Vehicles will be removed from buildings on **Saturday, March 28, 2026**. Vehicles **not removed by** this date **will be charged** an **additional \$5 per day, plus a \$25 charge for each moving.**
- 3. Use the premises in a careful manner and reimburse the Lessor for any damage due to his/her occupancy of said space.
- **4.** Be able to provide proof of insurance (if needed) in the form of a letter or certificate, and to release Lessor from any liability for any damage to the property of the Lessee while in the building or on the fairgrounds.
- 5. Surrender the use of the space temporarily at such times as the Lessor may have need of said space.
- **6.** During the said season, work is not permitted on vehicles.
- 7. All batteries and propane fuel tanks must be removed at time of storage.
